

Please read these Terms & Conditions, Privacy Policy and Transactional Services (or "Agreement", "Terms and Conditions", "Privacy Policy", "Online Transactions", "Transaction Service") carefully before using the website and services offered by Forstep Style Marketplace (or "Forstep Style", "we", "us", "our"). The Agreement sets out the legally binding terms and conditions for your use of the website at <https://forstepstyle.com> (the "Site") and all services provided by Forstep Style Marketplace on the Site.

By using the Site in any manner, including but not limited to visiting or browsing the Site, you (the "user" "you", or "seller(s)") agree to be bound by this Agreement, including those additional terms and conditions, privacy policy and transactional services and policies referred to here and/or available by hyperlink. This Agreement applies to all users of the Site, including without limitation users who are sellers, customers, merchants, contributors of content, information and other materials or services on the Site.

If you have any questions, please refer to the contact section of the Site.

WHAT IS FORSTEP STYLE FASHION MARKETPLACE?

Forstep Style marketplace is a platform that supports emerging and established fashion businesses. Forstep Style marketplace is an online fashion site which provides a platform for boutiques, fashion and cosmetic brands, fashion designers, concept shops, online fashion shops, handmade fashion designers, multi brand fashion stores, cosmetic shops and online fashion shops which are small, medium or large fashion businesses registered as a legal entities. (Selling their own label, street style collections, vintage collections, luxury collections or multi brands).

In other words, Forstep Style fashion marketplace is the place where anyone (*legal entity), anywhere, can sell fashion and beauty products, to anyone, anywhere.

Forstep Style Marketplace meets the needs of the customer by providing a place to discover unique fashion and/or beauty stores, designer items, cosmetics, boutiques as well as independent online boutiques. Forstep Style marketplace reserve the right to remove sellers that do not fall within this framework at any time.

Forstep Style Marketplace supports independent fashion labels that are small and medium businesses, and Forstep Style supports multi-brand stores that may possibly have their own store and are looking to diversify their selling options. In essence, we support sellers (Merchants) that have a legitimate business and are registered as a legal entity, which are falling under the fashion industry.

Forstep Style Marketplace supports small and medium fashion businesses. On Forstep Style, sellers (Merchants) own their stock physically and take their own pictures (or from their franchisor) used for their listings on the site. We do not support the drop shipping business model. If a seller is thought to be running

their business as a drop shipper then Forstep Style at its own discretion may remove that seller's account (s) from the site without notice or prior warning to the seller and shall take any measures it deems necessary to ensure that subsequent drop shipping accounts are not opened on the Site.

Forstep Style permits stores to list fashion gadgets and selected stationery items to complement their clothing and/or accessory ranges. Designs and photographs must be appropriate to Forstep Style's spirit. However, we know that this kind of restrictions, often seems to be subjective perception. Forstep Style Review Team reserve the right to remove any listing which they feel does not meet this criteria. Fashion gadgets: If making reference to third parties intellectual property rights, you must ensure that their intellectual property rights are used only where it is necessary to indicate the intended purpose of the fashion gadgets, in accordance with intellectual property law.

FORSTEP STYLE IS AN ONLINE FASHION PLATWORM (VENUE)

Forstep Style Marketplace acts as a venue to allow users, who comply with this agreement. Forstep Style Marketplace's policies to offer, sell and buy certain fashion and beauty goods within a fixed-price format. Forstep Style is directly involved in the transactions between buyers and sellers.

As a result, Forstep Style has total control over the financial transactions and has a full right to manage, process, approve, refund, or in rare cases to cancel money transactions. With respect to each item for which costumers have been paid on the site, costumers authorize Forstep Style (as applicable) to act as their agent with the relevant merchant from which costumers have bought item (s) from, for such item(s) that may be subject to dispute.

By placing your order, you agree to allow Forstep Style to collect amount of money for the applicable items in your order. This amount of money will be used, on customer behalf, to reimburse customer from such a failure for package to arrive at customer stated address. In other words, if the package doesn't arrive at time, or doesn't arrive at all, we will reimburse the amount back to costumer bank account.

Forstep Style Marketplace has no control over the quality, safety, morality or legality of any aspect of the items listed, the truth or accuracy of the listings, the ability of sellers to sell items or the ability of buyers to pay for items.

Forstep Style Marketplace has the right to pre-screen content or information provided by sellers. Forstep Style Marketplace can ensure that a buyer or seller will actually complete a transaction, because every payment transaction will be approved, canceled, on hold, refunded, or freezed by our side. Also, Forstep Style Marketplace cannot and does not transfer legal ownership of items from the seller to the buyer.

Forstep Style Marketplace cannot guarantee the true identity, age, and nationality of a user and encourages you to communicate directly with potential transaction partners through the tools available on the Site and asks that you do not arrange to meet users from the Site in person.

You agree that Forstep Style Marketplace is a venue and as such is not responsible or liable for any content, for example, data, text, information, usernames, graphics, images, photographs, profiles, audio, video, items, and links posted by you, other users, or outside parties on Forstep Style. You use Forstep Style service at your own risk.

SELLER MEMBERSHIP ELIGIBILITY

Age: Forstep Style's services are available only to, and may only be used by, legal entities who are professional businesses and may legally binding contracts under applicable law. You represent and warrant that you are at least 18 years old and that all registration information you submit is accurate and truthful. Forstep Style Marketplace may, in its sole discretion, refuse to offer access to or use of the Site to any person or entity and may change its eligibility criteria at any time without notice to you. This provision is void where prohibited by law and the right to access the Site is revoked in such jurisdictions.

Compliance: You agree to comply with all local laws regarding online conduct and acceptable content. You are responsible for all applicable taxes payable as a result of your activity on the Site. In addition, some services offered through the Site may be subject to additional terms and conditions published by Forstep Style Marketplace from time to time; your use of such services is subject to those additional terms and conditions, which are incorporated into this Agreement by this reference.

Password: Keep your password secure. You are fully responsible for all activity, liability and damage resulting from your failure to maintain password confidentiality. You agree to immediately notify Forstep Style of any unauthorised use of your password or any breach of security. You also agree that Forstep Style cannot and

will not be liable for any loss or damage arising from your failure to keep your password secure. You agree not to provide your username and/or password information to any other party other than Forstep Style without Forstep Style's express written permission.

Account Information: You must keep your account information up-to-date and accurate at all times, including a valid email and address. To sell fashion products and beauty products on Forstep Style you must provide and maintain a valid business bank account and a valid postal address.

Account Transfer: You may not transfer or sell your Forstep Style account and User ID to another party. If you are registering as a business entity, you personally guarantee that you have the authority to bind the entity to this Agreement.

Account Ownership: All of the stores on Forstep Style may only hold and operate one active selling account at any one time and the selling account must only be operated by the named account holder. If a secondary account is required then the store must request prior written permission from Forstep Style. Forstep Style reserves the right to reject any such request and may, at its discretion, terminate additional selling accounts or selling accounts being operated by a person other than the named account holder without prior warning.

Feedback: Marketplaces such as ours takes feedback integrity seriously. Sellers may offer small incentives for general feedback, however manipulation and/or bribery is not tolerated. This includes feedback from a related account, offering incentives/bribes in return for specific feedback. Forstep Style team reserve the right to remove any feedback which it suspects has been posted as a result of such manipulation or bribery and may close the seller account to which it relates.

Right to Refuse Service: Forstep Style reserves the right to refuse service to anyone at any time. Forstep Style's services are not available to temporarily or indefinitely suspended Forstep Style members. Forstep Style reserves the right, in sole discretion, to cancel unconfirmed or inactive accounts in anytime.

FEES AND SERVICES

Sellers on Forstep Style marketplace are not charged for a monthly subscription fee. Forstep Style charges a percentage of the sale price when the item sells. Forstep Style's Features and Fees are subject to change, are incorporated into this Agreement by reference. Increase to the Fees & Commission for Forstep Style's services are effective after Forstep Style provides you with at least thirty (30) days' notice by posting the changes on the Site. However, Forstep Style may choose to temporarily change the Fees & Commission for its services for promotional events; such changes are effective when Forstep Style posts the temporary promotional event on the Site. Forstep Style may decrease the fees as stated in the Fees & Commission with

no notice to you. Forstep Style may, at its sole discretion, change some or all of Forstep Style's services at any time. In the event Forstep Style introduces a new service, the fees for that service are effective at the launch of the new service. Unless otherwise stated, all fees are calculated in MKD at backend in accordance with the exchanging rate at the moment of the transaction

Seller accounts must stay up-to-date with all fees owed or the account may be suspended until all outstanding fees are paid in full. In the event that a Boutique's product count falls to zero their storefront will no longer show on site. Seller account can be closed or downgraded at any time and it is the responsibility of the store or boutique owner to manually terminate their store/boutique status from their Account page.

You are responsible for paying all fees and applicable taxes associated with using Forstep Style services. Forstep Style keeps accepted payment information in accordance with its Privacy Policy. If fees are due to Forstep Style then we will invoice the seller for the amount due that month. This amount will be taken automatically by Forstep Style Marketplace.

All fees are inclusive of VAT where applicable. In certain circumstances fees will not be subject to Macedonian VAT but you may be liable to indirect taxes in your own country. Forstep Style recommends that you research whether you are liable to declare such taxes to the relevant tax authorities. A valid VAT identification number is required from all sellers who are VAT-registered. Sellers outside of EU are liable to notify Forstep Style of any change in VAT status.

Fees and Termination: If Forstep Style terminates your account, if you close your account, or if the payment of your Forstep Style fees cannot be completed for any reason, you remain obligated to pay Forstep Style for all unpaid fees plus any penalties, if applicable. If the seller's account is not paid in full, the seller risks penalties such as the suspension of privileges, termination of the account and/or legal action. If you have a question or wish to dispute a charge, contact Forstep Style as soon as possible.

LISTING AND SELLING

Listing Description: By listing an item on the Site you warrant that you and all aspects of the item comply with Forstep Style's published policies. You also warrant that you may legally sell the item. You must accurately describe your item and all terms of sale in your listing. Your listings may only include text descriptions, pictures and other content relevant to the sale of that item. All items must be listed in an appropriate category with appropriate tags. You must not list an item more than once, unless the item's listing has naturally expired. If the "in stock" quantity is more than one, all items in that listing must be identical with the only exception being minor variations arising from items being hand-finished which must be included on the listing.

Binding Sale: All sales are binding. The seller is responsible for shipping up to the point of delivery or otherwise completing the transaction with the buyer within 20 days, unless there is an exceptional circumstance, such as: (a) the buyer fails to meet the terms of the seller's listing (such as payment or delivery method), or (b) the seller cannot authenticate the buyer's identity. The buyer is obligated to deliver appropriate payment for items purchased, unless there is an exceptional circumstance.

Fee Avoidance: The price stated in each item listing description must be an accurate representation of the sale. Sellers may charge reasonable shipping and handling fees to cover the costs for packaging. Sellers may not charge excessive shipping fees or otherwise avoid fees. You may not alter the item's price after a sale for the purpose of avoiding Forstep Style Marketplace transaction fees, misrepresent the item's location, or use another user's account without permission. Sellers may not encourage buyers to purchase an item listed on Forstep Style Marketplace outside of Forstep Style Marketplace site, such as directly through their business bank account. This may also constitute fee avoidance.

Promotional Codes: Sellers may issue promotional codes for promotional purposes only and these are to be used against purchases from the issuing seller's store only. Promotional codes have no cash value and cannot be exchanged for money or credit. Sellers are expressly prohibited from selling promotional codes for their store and/or Forstep Style site. If the Seller is found to be selling promotional codes this may constitute fee avoidance.

Forstep Style has the right to use seller's content which is provided by their side for a marketing and promotion purposes.

Depending on the services you choose, we may collect additional information, for example: information in private channels like support conversations between you and registered users on the Site, boutique’s physical street address, country, state and city information. We may also collect company billing information, such as company’s business bank account, bank name, personal ID and/or tax ID, a business telephone number, business social media URL and personal identification documents that proves boutiques identity. Please note that for security and performance reasons, such content may need to be accessed by certain Forstep Style personnel from time to time. Your boutique name is publicly displayed and connected to your activity on the Site. Like many sites, this Site employs cookies and web beacons (also known as clear GIF technology or "action tags") to speed your navigation of the Site, recognize you and your access privileges, and track your Site usage.

Cookies are small pieces of information that are stored as text files by your Internet browser on your computer's hard drive. Most Internet browsers are initially set to accept cookies. You can set your browser

to refuse cookies from web sites or to remove cookies from your hard drive, but if you do, you will not be able to access or use portions of this Site. We have to use cookies to enable you to select products, place them in an online shopping cart, and to purchase those products. Communications with You: We will use your business information to communicate with you about our site and your orders, refunds, returns, disputes and deliveries. Information Collected or Received

As a seller on Forstep Style Marketplace you are required to provide a valid shop name, valid valid email address and a valid phone number at registration that represents and proves your shop identity on Forstep Style.

Depending on which services you choose to use, Forstep Style may require additional information to provide the service, such as your shop name, billing and payment information, including billing address, telephone number, credit card information, your business home bank, telephone number, and/or a physical postal address. Sellers on Forstep Style are obligated to verify their business presence on the Site, therefore we require to provide us valid ID and/or VAT proof, such as business ID card or driving license. That way you can decide whether you want to continue using the Site. Changes will be effective upon the posting of the changes. You are responsible for reviewing and becoming familiar with any changes. Your use of the Site following the changes constitutes your acceptance of the updated policy.

Changes to this Privacy Policy

Any changes to this Privacy Policy will be communicated by us posting an amended and restated Privacy Policy on the Site. Once posted on the Site the new Privacy Policy will be effective immediately. You agree that any information we hold about you (as described in this Privacy Policy and whether or not collected prior to or after the new Privacy Policy became effective) will be governed by the latest version of the Privacy Policy.

Transactional Services

Forstep Style's Transaction Service are designed to facilitate registered members of the Site to place, accept, conclude, manage and fulfill orders for the provision of products and services online within the Site ("Online Transactions"), which may include certain services which will be either supported by third parties. (a) may infringe Forstep Style's or any third party's legitimate rights including but not limited to copyright, trademark right, patent or other intellectual property rights.

(b) may be in breach of the Privacy Policy, Terms and Conditions or the Intellectual Property Right (IPR) Protection Policy;

(c) may be in breach of other terms of this Agreement including the Transactional Terms and the General Terms.

Forstep Style shall have the right to refuse or cancel any Online Transaction in breach of this clause 2.4. of transactions, benefits, features and functions will be available to all members.

2.5 Refuse or Cancel Transactions. Apart from clause 2.4, Forstep Style reserves the right, at our sole discretion, to refuse, on hold or cancel any Online Transaction for any reason. Some situations that may result in an Online Transaction being rejected or canceled include where problems are identified by our side, where Forstep Style has reason to believe the Online Transaction is unauthorized, violates any law, rule or regulations or may otherwise subject Forstep Style to liability.

2.6 Buyer Protection Plan. Forstep Style provide buyer protection plan for all Online Transactions made on the Site. All professional sellers on Forstep Style, upon entering into this agreement with Forstep Style, hereby authorise Forstep Style to withhold all the financial transaction made on the Site on our business

bank account up to 90 days from the transaction day. However, this are extremely rare situations, usually caused by third parties such as shipping services or customs delays. Seller agrees to permit and hereby authorize Forstep Style to deduct, manage, withhold and dispose any transactions provided in accordance with the terms under the relevant buyer protection plan. Buyer acknowledges and agrees that the protection afforded to you under a buyer protection applies to all Online Transactions where the Seller agreed to such agreement and the purchase falls within the buyer protection's scope. Buyer acknowledges and agrees Forstep Style to withhold and then release to seller all the Online Transaction made on the Site on Forstep Style's business bank account up to 90 days from the transaction day within the scope of buyer protection plan. The guarantee service will be performed according to the agreement reached between the guarantee service provider and the Seller.

2.7 Transactional Terms. For any type of Online Transactions, Forstep Style may impose additional restrictions, limitations and prohibitions as well as penalties for any violations in the relevant Transactional Terms.
